Captains that fish the same fishery for different CDQ/CA groups must complete separate applications for each CDQ/CA group they fish. CDQ/CA groups must register with ADFG and provide the Commercial Fisheries Entry Commission with the names of the captains and vessels harvesting their allocations. Payment may be submitted by check, money order or the attached credit card authorization. Additionally, you may submit your 2025 Crab CDQ and Community Allocation Permit Application form by fax or mail. All sections of this form must be completed to avoid delays in issuing your permit(s).
