#### **General Information:**

Please use this form if the proposed transferee already holds the same type of salmon permit (area and gear) except Cook Inlet set gillnet, Cook Inlet drift gillnet and Yakutat set gillnet, otherwise use the *Request for Permanent Transfer of Entry Permit* form.

Limited Entry Permits cannot be:

- Leased
- Distrained
- Transferred with any retained right of repossession or foreclosure
- Pledged
   Mortgaged
   Transferred with any re Encumbered in any ward
- Attached

Encumbered in any way, or on any condition requiring a subsequent transfer

Once a permit is transferred, the new owner is the permit holder and no one else can have control or an interest in the permit.

Note that permanent transfers are not official or final until all required documentation has been received and approved by the Commercial Fisheries Entry Commission, even if money has already been paid and documents signed.

Information on financing is available from the DED, phone 907-465-2510 or CFAB, phone 907-276-2007. An entry permit cannot be permanently transferred while it is subject to a lien filed by DED, CFAB, Child Support Services Division (CSSD), or the Internal Revenue Service (IRS). The parties to a permit transfer are advised to take appropriate measures to protect themselves from the risks associated with federal tax liens.

#### Instructions:

To request a permanent transfer:

- The entire form must be completed by both the permit holder and transferee.
- The current year permit card (if issued) must be returned.
- A \$50.00 transfer fee must be submitted.
- Both parties must have their signatures notarized (they do not have to sign at the same time or place).
- A copy of the "transfer agreement" or "bill of sale" outlining all terms and conditions of the transfer must be submitted providing full disclosure, as required by CFEC regulation 20 AAC 05.1712(c)
- The Request for Permanent Transfer for the Purpose of Fleet Consolidation form must be submitted to CFEC within 90 days of being signed and notarized

If a permit is held by a deceased fisherman's estate, only the legally authorized representative of the estate can complete the transfer documents. A copy of the Letters of Administration or Letters Testamentary verifying that person's legal authority must be submitted with the transfer request.

#### **Payment Information:**

Payment may be made using the attached credit card authorization and submitted via mail or fax. We also accept checks, money orders, and cashier's checks.

## **DEFINITIONS:**

- **Gift** a voluntary transfer of property from one person to another, free of charge, without anything given in return.
- **Transferor** the person who currently owns the property, who is transferring ownership of the property to the transferee.
- **Transferee** the person being given ownership of the property by the transferor.

## **CONSEQUENCES OF SIGNING:**




