## NOTICE OF PROPOSED CHANGES ON FISHERY RESOURCE, GEAR, AND ADMINISTRATIVE AREA CODES IN THE REGULATIONS OF THE ALASKA COMMERCIAL FISHERIES ENTRY COMMISSION

## **BRIEF DESCRIPTION**

The Alaska Commercial Fisheries Entry Commission proposes to change regulations by adding new fishery, gear and administrative area codes.

The Alaska Commercial Fisheries Entry Commission (commission) proposes to adopt regulation changes in 20 AAC 05 of the Alaska Administrative Code, dealing with adding new fishery resource, gear, and administrative area codes, including the following:

- (1) 20 AAC 05.210. Fishery resource codes, is proposed to be changed by adding fishery species codes for Arctic lamprey and Pacific cod. Currently neither are in regulation. There is a small developing lamprey fishery in Western Alaska that is currently permitted as a miscellaneous freshwater species. There are Pacific cod fisheries currently permitted as "miscellaneous saltwater finfish." These changes will help with data integrity, and in the case of Pacific cod, improve the commission's ability to respond to petitions to limit a fishery.
- (2) 20 AAC 05.220. Gear codes, is proposed to be changed by allowing the use of a dipnet under a set gillnet permit in the Cook Inlet and Yukon set gillnet fisheries as authorized by the Board of Fisheries, adding a new pot gear code specifically for registered vessel length under 35 feet, and adding new individual gear codes for fyke net and dipnet. There is interest in creating a new permit category for smaller boats in the Pacific cod pot fishery to possibly make the cost of entry more reasonable. Fyke nets are used in the Western Alaska lamprey fishery, which is currently coded to set gillnet gear. Dip nets are becoming assigned more frequently by the Board of Fisheries as commercial fishing gear.
- (3) 20 AAC 05.230. Administrative areas, is proposed to be changed by adding areas for Pacific cod fisheries. These fisheries are defined in Board of Fisheries regulations. The commission permits these fisheries under on "statewide" delineation. The commission has received petitions to limit participation in certain Pacific cod regions, but cannot analyze these fisheries without more defined administrative areas.

The comments must be received not later than 5:00pm on June 13, 2024.

The language of the final regulation may be different from that of the proposed regulation. You should comment during the time allowed if your interests could be affected.

**Fiscal information:** The proposed regulation changes are not expected to require an increased appropriation.
