NOTICE OF PUBLIC MEETING

Alaska Department of Fish and Game Prince William Sound commercial pot shrimp fishery preseason management meeting

and

Commercial Fisheries Entry Commission Public Hearing on draft proposed regulations to limit the Prince William Sound commercial shrimp pot fishery.

The Commercial Fisheries Entry Commission (commission) is holding public meeting in Anchorage on **March 26, 2024**, at the Egan Civic and Convention Center located at 555 West 5th Avenue and through web conference. The meeting will occur immediately after the Alaska Department of Fish and Game (ADF&G), Division of Commercial Fisheries Prince William Sound (PWS) commercial shrimp fishery 2024 season management review to start at 5:30pm. The meeting will be held in the Joint Board of Game and Fisheries meeting room located at the Egan Center.

This commission meeting will be held to discuss the development of draft proposed regulations to limit the PWS commercial shrimp pot fishery. Once the draft regulations are finalized, the final proposed regulations will be noticed for further public comment pursuant to the Administrative Procedure Act (AS 44.62.190).

The Limited Entry Act (the Act) limits the number of commercial fishing permits allowed to operate within designated fisheries in Alaska. The Commission was established in 1973 in order to administer the Act (AS 16.43.010). The stated purpose of the act is to promote the conservation and sustained yield management of Alaska's fishery resources. Additionally, the Act seeks to uphold the economic health and stability of the commercial fishing industry in Alaska.

In December of 2021, the commission was petitioned to limit the PWS commercial shrimp pot fishery. Following a lengthy review involving analysis on historic fisheries information, a public hearing, and a survey of the fleet, the commission voted to propose limiting the fishery in December 2023.

Since that time the commission drafted proposed regulations to establish a maximum number of permits to issue, the participation period years, and an application scoring system. The draft

regulations are under review by the Department of Law and will be separately noticed and published for public comment when approved. The public will have at minimum 30-days to respond. Following review and response to public comment, the commission will make a final decision on how to limit the fishery.

The commission will use its meeting on March 26 to introduce the draft proposed regulation to meeting participants and seek public comment. While not in its official public comment period, the commission will nonetheless take all public comments through public testimony at the meeting into consideration and include them in its response to the public comments received on the proposed regulations. By March 18, 2024, a tentative agenda will be posted on the commission's website and at its office. This agenda will also be available by request. A copy of the draft proposed regulations are also available on the commission website and upon request.

The public is invited to attend the meeting. The ADF&G season review and CFEC public hearing will be available via a web conference link. Use the following web instructions to participate virtually:

20 AAC 05.839. Point system for the Prince William Sound shrimp pot fishery. (a) Past Participation and Economic Dependence. The commission will award a maximum of 44 points to an applicant for participation in, and economic dependence on, the Prince William Sound Alaska shrimp pot fishery as follows:

(1) The commission will award a maximum of 36 points to applicants who commercially harvested shrimp caught with pot gear from the fishery over the January 1, 2019 – December 31, 2022, time period based on the years in which they participated according to the poundage thresholds established for each year as follows:

(2) the commission will award an additional 4 points to an applicant whocommercially harvested more than 2000 pounds of shrimp caught with pot gear over the2019 to 2022 time period; and

(3) The commission will award an additional 4 points to an applicant who made commercial deliveries in the Prince William Sound shrimp pot fishery in three of the four qualifying years listed in 20 AAC 05.837.

(b) Consistent Participation and Economic Dependence. The commission will award a maximum of 32 points to an applicant for consistent participation, investment, and economic dependence on the Prince William Sound Alaska shrimp pot fishery as follows:

(1) The commission will award a maximum of 16 points to an applicant for consistent participation based on a minimum number of pounds harvested or a minimum number of deliveries made in a year as follows:

(2) The commission will award an additional 2 points for any year within the four-year qualifying period listed in 20 AAC 05.837 where an applicant made commercial shrimp harvests and obtained a catcher/seller permit as defined in 5 AAC 39.130(o)(4). if the applicant did not obtain a catcher/processor permit in that same calendar year.

(3) The commission will award an additional 4 points for any year within the four-year qualifying period where the applicant made commercial shrimp harvests and obtained a catcher/processor permit as regulated by 18AAC 34. (Eff. __/_/___, Register ___)

(a) The commission designates priority classifications 25 - 76 as classifications of applicants for the Prince William Sound shrimp pot fishery who would suffer significant economic hardship if they do not get a permit from the state, and who will receive a permanent transferrable permit as required by AS 16.43.270(a).

(b) The commission designates the priority classifications 0 - 15 as classifications of applicants for the Prince William Sound shrimp pot fishery who would suffer only minor economic hardship without the issuance of a permit from the state, and an entry permit originally issued to those applicants by the commission under AS 16.43.250(c) will receive a permanent non-transferrable permit. (c) "pounds" means actual pounds of whole shrimp recorded on fish tickets, if the weight for shrimp tails is recorded on fish tickets, pounds of whole shrimp is calculated by multiplying tail weight by the Department of Fish and Game's conversion factor of 1.67 for all shrimp species and all size classes of shrimp.
